The Empire State Poverty Reduction Initiative (ESPRI) is funded by the New York State Office of Temporary and Disability Assistance

In his 2016 State of the State address, Governor Cuomo announced the Empire State Poverty Reduction Initiative (ESPRI); a community based initiative to combat poverty. Sixteen communities across New York State were selected based on their high rates of poverty. The City of Oneonta was one chosen community, as it has a very high rate of poverty, with 18% of youth under 18 years old living in poverty.

The City of Oneonta designated Opportunities for Otsego to coordinate the City of Oneonta's poverty reduction initiative. Opportunities for Otsego will lead ESPRI activities and work with community leaders to identify barriers and implement strategies to combat poverty.
