SERVICES INCLUDE EMERGENCY SHELTER, RENTAL SUBSIDIES, HOUSING LOCATION ASSISTANCE, ACCESS TO SUPPORT SERVICES, AND INDIVIDUAL CASE MANAGEMENT.
